It may be recalled that as per General Financial Rules (GFRs), 2017 and subsequent instructions issued by Department of Public Enterprises (DPE), it is mandatory for Ministries/Departments/Central Public Sector Enterprises (CPSEs) to make procurement of common use goods and services only from Government e-Marketplace (GeM), if the items/services are available on the GeM. Many of the CPSEs are also sellers/service providers of goods and services to Government organisations.

- 2. In this context, GeM during the quarterly review meeting held in this Department on 22<sup>nd</sup> March, 2021 had informed that many of the CPSEs are still not registered on GeM as sellers. Absence of CPSEs on GeM as sellers reduces competition and deprives the Government buyers the opportunities to get the competitive prices. Simultaneously, CPSEs may also be losing business opportunities arising from the Government buyers.
- 3. In view of above, it is requested to consider issuing instructions to all CPSEs which have any product which may be purchased by Government departments to get themselves registered on GeM. It possible that due to small value bids, CPSEs themselves may not like to participate in the bidding process on GeM, hence CPSEs may also be directed to register their authorised resellers as well on GeM.
