Ministry of MSME have been receiving complaints regarding false, or incorrect, information mentioned by some of the enterprises while obtaining UAM online and applying/ availing of the benefits of various schemes of the Ministry, in general and under the Public Procurement Policy (PPP) in particular.

- At present, MSME enterprises are categorised as such on the basis of guidelines contained in the provisions of the MSMED Act, 2006 and notification No. S.O. 1722(E) dated 5.10.2006. Copy of the same is enclosed.
- It is hereby clarified that while awarding contract to the MSEs under the Public Procurement Policy (PPP), the Government Departments/ CPSEs/ other organizations shall satisfy themselves about the MSE status of the concerned enterprises. In case of any doubt/ lack of evidence in respect of the MSE status of any enterprise, they may go through due verification process with the help of supporting documents such as CA Certificate, details available from the website of Ministry of Corporate Affairs etc.
- The General Managers of the District Industries Centre of the concerned district are authorised to undertake enquiry and verify the credentials of the memorandum submitted by the enterprise as mentioned in clause 13 of the Notification No. S.O. 2052(E) dated 30.6.2017. Copy of the same is enclosed.

#### NOTIFICATION

New Delhi, the 5th October, 2006

s.O. 1722(E).—In exercise of the powers conferred by sub-section (1) of section 7 of the Micro, Small and Medium Enterprises Development Act, 2006(27 of 2006) herein referred to as the said Act, the Central Government hereby specifies the following items, the cost of which shall be excluded while calculating the investment in plant and machinery in the case of the enterprises mentioned in section 7(1)(a) of the said Act, namely:-

- (i) equipment such as tools, jigs, dies, moulds and spare parts for maintenance and the cost of consumable stores;
- (ii) installation of plant and machinery;
- (iii) research and development equipment and pollution control equipment;
- (iv) power generation set and extra transformer installed by the enterprise as per the regulations of the State Electricity Board;
- (v) bank charges and service charges paid to the National Small Industries Corporation or the State Small Industries Corporation;
- (vi) procurement or installation of cables, wiring, bus bars, electrical control panels (not mounted on individual machines), oil circuit

breakers or miniature circuit breakers which are necessarily to be used for providing electrical power to the plant and machinery or for safety measures;

- (vii) gas producer plants;
- (viii) transportation charges (excluding sales-tax or value added tax and excise duty) for indigenous machinery from the place of their manufacture to the site of the enterprise;
- (ix) charges paid for technical know-how for erection of plant and machinery;
- such storage tanks which store raw materials and finished products
   only and are not linked with the manufacturing process; and
- (xi) fire fighting equipment.
- 2. While calculating the investment in plant and machinery referred to in paragraph 1, the original price thereof, irrespective of whether the plant and machinery are new or second hand, shall be taken into account provided that in the case of imported machinery, the following shall be included in calculating the value, namely:
  - (i) Import duty (excluding miscellaneous expenses such as transportation from the port to the site of the factory, demurrage paid at the port);
  - (ii) Shipping charges;
  - (iii) Customs clearance charges; and
  - (iv) Sales tax or value added tax.

New Delhi, the 30th June, 2017

S.O. 2052(E).—In exercise of the powers conferred by sub-section (2) of the section 8 of the Micro, Small and Medium Enterprises Development Act, 2006 (27 of 2006), hereinafter referred to as the said Act, and in supersession of the notification of the Government of India in the Ministry of Micro, Small and Medium Enterprises number S.O. 85(E), dated the 10<sup>th</sup> January, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii), dated the 10<sup>th</sup> January, 2017 except as respects things done or omitted to be done before such supersession, the Central Government, after obtaining the recommendations of the Advisory Committee in this behalf,

hereby specifies that any micro, small and medium enterprise shall file Udyog Aadhaar Memorandum (hereafter, referred to as the memorandum) in Form-I appended to this notification, in accordance with the following procedure, namely:—

- (1) The memorandum shall be filed online on the website of the Ministry of Micro. Small and Medium Enterprises, Government of India at http://udyogaadhaar.gov.in;
- (2) Every micro, small and medium enterprise engaged in the manufacturing of goods or rendering of services with total investment in plant and machinery within the limit specified in section 7 of the said Act, shall file the memorandum;
- (3) Any number of activities including manufacturing or service or both may be specified in the memorandum;
- (4) The proprietor in the case of a proprietorship firm, managing partner in the case of a partnership firm and a karta in the case of a Hindu Undivided Family(HUF), shall provide his Aadhaar Number in the memorandum;
- (5) In case of a company or a limited liability partnership or a cooperative society or a society or a trust, Permanent Account Number(PAN) of the organisation along with Audhaar number of the authorised signatory shall be specified in the memorandum;
- (6) A one time password (QTP) for verification of the fresh memorandum as well as amending of the existing memorandum shall be sent on mobile phone linked to the Aadhaar number of the applicant and the applicant shall-enterthe OTP in the form before submitting the memorandum;
- (7) The memorandum shall be filed on self-certification basis and no additional document is required to be uploaded at the time of such filing:

Provided that the Central Government or the State Government or such person as may be authorised in this behalf may seek documentary proof of the information provided in the memorandum, wherever necessary;

- (8) United Action Registrich Court his to the generated and mailed to the email address provided in the memorandum;
- (9) There shall be no fee for filing the Udyog Aadhaar Memorandum;
- (10) In case an applicant or the authorised signatory does not have Aadhaar number or in cases where online filing is not possible for any reason, a hard copy of the duly filled Form I, shall be submitted to the concerned District Industries Center (DIC) or to the Office of the Micro, Small and Medium Enterprise-Development Institute (MSME-DI) under the Development Commissioner, MSME alongwith the following documents as alternative and viable means of identification:
  - (a) (i) Aadhaar enrolment ID slip; or
    - (ii) a copy of the request made for Aadhaar enrolment; or
  - (b) any of the following documents of the applicant or the authorised signatory, namely:-
    - (i) Bank photo passbook: or
    - (ii) voter ID Card; or
    - (iii) passport; or
    - (iv) driving license; or
    - (v) PAN card; or
    - (vi) employee photo identity card issued by the Government.
- (11) No enterprise shall file more than one memorandum:
- (12) In case of change in address or addition of defetion of activities by the enterprises or for other changes, the proprietor or the managing partner or an authorised person may apply for amendment of the existing memorandum in accordance with the guidelines for filing the online Udyog Andhaar Memorandum provided in the website of the Ministry of Micro. Small and Medium Enterprises, at http://udyogaadhaar.gov.in;
- (13) The General Manager of the District Industries Center of the concerned district shall undertake enquiry and verification of the memorandum submitted by the enterprise and in case of any discrepancy, issue a notice to the enterprise, giving it an opportunity to present its case and based on the findings, he may amend the memorandum or cancel the Registration Certificate if already issued.


- Enterprises that have filed EM-II or SSI registration, shall not be required to file UAM but may file it, if they so
