## विषयः जेम के माध्यम से वस्तुओं और सेवाओं की खरीद और एमएसएमई विक्रेताओं/कॉन्ट्रैक्टर्स के बकाया राशी का समय पर निपटान।

वस्तुओं और सेवाओं की खरीद सरकारी ई-मार्केटिंग (जेम) पोर्टल से की जानी है। जेम 4.0 का नया संस्करण हाल ही में लॉन्च किया गया है और इसमें खरीदारों के लाभ के लिए यू ट्यूब निर्देश, प्रशिक्षण सुविधा प्रदाता आदि सहित विभिन्न विवरण उपलब्ध हैं (gem.gov.in)।

लोक उद्यम विभाग द्वारा जारी 21 मई 2020 के कार्यालय ज्ञापन (प्रति संलग्न अनुलग्नक-। के रूप में) के अनुसार, मंत्रालय ने सार्वजनिक क्षेत्र के उपक्रमों के लिए वर्ष 2020-21 के समझौता ज्ञापन लक्ष्य में 5 अंकों के वेटेज के साथ एक अनिवार्य मानदंड लागू किया है। अतः, सभी से अनुरोध है कि वे जेम खरीद प्रक्रिया से परिचित हो जाएँ और यह सुनिश्चित करें कि अधिकांश खरीद जेम पोर्टल के माध्यम से की जाए ताकि समझौता ज्ञापन लक्ष्य प्राप्त किया जा सके।

- सभी खरीद अनिवार्य आवश्यकताओं के रूप में जेम पोर्टल से की जानी है। खरीद के तौर-तरीकों और जेम पोर्टल में बताई गई प्रक्रियाओं का सख्ती से पालन किया जाना चाहिए। इसमें विविध, प्रत्यक्ष खरीद, न्यूनतम बोली, निविदा और एकल ब्रांडों के लिए मालिकाना खरीद आदि सभी तरीके शामिल होंगे।
- केवल, यदि उत्पाद/सेवा जेम पोर्टल पर उपलब्ध नहीं है, तो उसे जेम पोर्टल से प्रिंटआउट के साथ फ़ाइल में दर्ज किया जाना चाहिए और फिर हडको की खरीद नियमावली के अनुसार खरीद के अन्य तरीके से आगे बढ़ना चाहिए।
- खरीदारी करते समय यह सुनिश्चित किया जाना चाहिए कि कुल खरीद का 25% एमएसएमई से हो,
   जिसमें से 4% एससी/एसटी से और 3% महिला उद्यमियों से हो।
- सभी से अनुरोध है कि वे अपना व्यक्तिगत hudco.org ईमेल पता प्राप्त करें और सभी दैनिक आधिकारिक संचार के लिए उसका उपयोग करें। जेम वेबसाइट Gmail, Yahoo मेल आदि के स्थान पर आधिकारिक ईमेल पते को प्राथमिकता देती है।
- सभी क्षेत्रीय कार्यालय (आरओ) मौजूदा विक्रेताओं/सेवा प्रदाताओं को जेम/एमएसएमई में नामांकन कराने की सलाह देने के लिए भी पहल कर सकते हैं।

• वैधानिक आवश्यकताओं के एक भाग के रूप में, हडको ने जेम पोर्टल में पंजीकरण कराया है और ट्रेड्स पोर्टल में नामांकन कराया है।

मुख्यालय/आरओएस/एचएसएमआई के सभी खरीद विभागों से अनुरोध है कि वे वर्ष 2019-20 के दौरान कुल खरीद और जेम पोर्टल के माध्यम से की गई खरीद की जानकारी प्रशासन विभाग, मुख्यालय की ई-मेल आईडीadmnhudco@gmail.com पर प्रस्तुत करें।

एमएसएमई मंत्रालय, नई दिल्ली, भारत सरकार के दिनांक 22 मई, 2020 के पत्र और वित्त मंत्रालय, भारत सरकार के दिनांक 14 मई, 2020 और 21 मई, 2020 के पत्रों के अनुसार, व्यय विभाग (अनुलग्नक-॥ के रूप में संलग्न प्रति) ने भी निम्नलिखित का ध्यान रखने का निर्देश दिया है:

- भारतीय एमएसएमई और अन्य कंपनियों को अक्सर विदेशी कंपनियों से अनुचित प्रतिस्पर्धा का सामना करना पड़ता है, इसलिए यह निर्णय लिया गया है कि 200 करोड़ रुपये तक की सरकारी खरीद निविदाओं में वैश्विक निविदाओं की अनुमित नहीं दी जाएगी। यह आत्मिनर्भर भारत की दिशा में एक कदम होगा और मेक इन इंडिया को बढ़ावा देगा। इससे एमएसएमई को अपना व्यवसाय बढ़ाने में भी मदद मिलेगी।
- एमएसएमई विक्रेताओं/ कॉन्ट्रैक्टर्स के बकाया का भुगतान सरकार/सार्वजनिक क्षेत्र के उपक्रमों द्वारा
   45 दिनों के भीतर किया जाना चाहिए।

अगले महीने एचएसएमआई द्वारा एक वेबिनार प्रशिक्षण कार्यक्रम भी प्रस्तावित है ताकि एमएसएमई से संबंधित जेम खरीद और अनुपालन से संबंधित किसी भी संदेह का समाधान किया जा सके।

यह सभी विभागाध्यक्षों, एचएसएमआई और क्षेत्रीय कार्यालयों द्वारा सख्ती से अनुपालन हेतु।

Sub: Procurement of Goods and Services through GeM and timely settlement of dues of MSME Vendors/Contractors.

The Procurement of Good and Services has to be made from Government E - Marketing (GeM) Portal. The New Version of GeM 4.0 has been launched recently and it has various details including You Tube instruction, training facilitators etc., for the benefit of purchasers (gem.gov.in).

As per the OM dated 21st May 2020, issued by Department of Public Enterprises, (copy enclosed as Annexure-I) the Ministry has introduced compulsory parameter with weightage of 5 Marks in the MoU target for the Year 2020-21 for PSUs. Hence, all are requested to get familiarize with GeM procurement process and ensure most of the procurement's are made through GeM portal to achieve MoU target:

- All Procurement are to be made from GeM Portal as a Mandatory requirements. The modalities of procurement are the processes as indicated in the GeM portal have to be strictly followed. This will include all modes like Misc, direct purchase, minimum bidding, tendering and proprietary purchases for single brands etc.
- Only, If the Product/Service is not available in GeM portal, then the same need to be recorded on the file with a printout from GeM portal and then proceed through other mode of purchase as per HUDCOs Purchase Manual.
- While procurements are made it may be ensured that 25% of Total procurement has to be from MSME, out of this 4% from SC/ST and 3% from Women Entrepreneurs.
- All are requested to get their individual hudco.org, E Mail address and use the same for all day to day official communications. The GeM website prefers official E Mail address in place of Gmail, Yahoo mail...etc.

- ROs can also take initiatives to advice the present Sellers /Service Providers to Enroll themselves in GeM /MSME.
- As a part of statutory requirements HUDCO has registered in GeM portal and enrolled in TReDs portal.

All Procurement Departments at HQ/ROs/HSMI are requested to furnish the information of total purchase & purchases made through GeM portal during the year 2019-20 on Admn Wing, Head Office E-mail ID – admnhudco@gmail.com

As per the letter dated 22<sup>nd</sup> May, 2020 of Govt. of India, Ministry of MSME, New Delhi alongwith letters dated 14<sup>th</sup> May, 2020 & 21<sup>st</sup> May, 2020 , Govt. of India, Ministry of Finance Department of Expenditure (copy enclosed as Annexure-II) has also instructed to take care of the following:

- Indian MSME and other Companies have often faced unfair competition from Foreign Companies, therefore it has been decided that Global Tender will be disallowed in Govt. procurement Tenders upto 200 Crores. This will be a step towards Self Reliant India (आत्म निर्भर भारत) and support Make in India. This will also help MSME to increase their Business.
- Settlement of dues of MSME Vendors/Contractors should be settled within 45 days by Govt./PSUs.

A Webinar Training Schedule is also proposed by HSMI next month to sort out any doubts related to GeM procurement and compliance related to MSME.

This is for Strict Compliance by All HoDs, HSMI & Regional Offices.

It may also be recalled that while announcing the economic package recently, Hon'ble Finance Minister had included this item as an important announcement and had directed that such dues be settled within 45 days.

Pursuant to the announcement by Hon'ble Finance Minister, I have requested all the Secretaries of Government of India to kindly monitor this issue so as to pay receivables as per the said announcement. I take this opportunity to reiterate that point.

So far, Department of Expenditure has been reviewing the pendency of bills from top CPSEs. However, now as desired by Secretary (Expenditure) vide the above letter, this task will be led and conducted by us in the Ministry of MSME. The Department of Expenditure and Department of Public Enterprises would also be involved in the exercise. As desired by Secretary (Expenditure), Department of Public Enterprises is also requested to make this a priority in the "Performance Related Pay" of the senior management of the CPSEs.

Details of the outstanding dues of MSMEs are available at our portal samadhaan.msme.gov.in.

I also take this opportunity to reiterate my another request which is to see that the Government Agencies and CPSEs join the TReDS platform and take effective part on the same.

In the above background, we will be shortly convening meetings to review the situation. I request you to kindly issue necessary instructions in this regard and see that the dues are settled.

As you are already aware, Hon'ble Prime Minister while addressing the nation on 12.05.2020 had announced an economic stimulus package of INR 20 lakh crore to combat the impact of COVID 19 and to move towards the goal of a self-reliant India. In a first step towards this direction, Hon'ble Finance Minister has announced the first tranche of measures to boost the economy on 13.05.2020.

- 2. The following measures have been announced in respect of your Ministry in the first tranche of economic package:
- Global tenders will be disallowed in Government procurement tenders upto Rs 200 crores
  - a. Indian MSMEs and other companies have often faced unfair competition from foreign companies Therefore, Global tenders will be disallowed in Government procurement tenders upto Rs 200 crores.
  - b. Necessary amendments of General Financial Rules will be effected.
  - c. This will be a step towards Self-Reliant India (आत्मनिर्भर भारत) and support Make in India
  - d. This will also help MSMEs to increase their business.

#### B. Relief to Contractors

- Extension of up to 6 months (without costs to contractor) to be provided by all Central Agencies (like Railways, Ministry of Road Transport & Highways, Central Public Works Dept, etc)
- b. Covers construction/ works and goods and services contracts
- Covers obligations like completion of work, intermediate milestones etc.
   and extension of Concession period in PPP contracts
- d. Government agencies to partially release bank guarantees, to the extent contracts are partially completed, to ease cash flows

C. Settlement of dues to MSME vendors from Government and Central Public Sector Undertakings.

MSME receivables from Government and CPSEs to be released in 45 days

3. I shall be grateful if you could take urgent action for implementation of the announcements concerning your Department and keep us posted on the developments

It is noted from the letter that one of the announcement regarding settlement of dues to MSME vendors from Government and Central Public Sector Enterprises (CPSEs) within 45 days, pertains to your Ministry.
- It is requested to take urgent action for implementation of the announcement and the action taken report may kindly be sent directly to Department of Economic Affairs.
- In this regard, Department of Expenditure has been reviewing the pendency of bills from top CPSEs in recent months. However, it is not a direct focus of this Department nor is it a subject of this Department under the Allocation of Business Rules. I feel this may work better and more effectively if led/conducted by your Department. We will also support this effort. The Department of Public Enterprises could also be involved, and they may be asked to make this a priority in the "Performance Related Pay" of the senior management of PSEs.
