**संदर्भ:** 1. प्रधान लेखा कार्यालय (प्रशासन), आवासन एवं शहरी कार्य मंत्रालय, निर्माण भवन, नई दिल्ली, भारत सरकार का दिनांक 06.01.2022 का कार्यालय ज्ञापन

2. प्रोक्योरमेंट नीति प्रभाग, व्यय विभाग, वित्त मंत्रालय, लोक नायक भवन, भारत सरकार का दिनांक 24 अगस्त, 2022 का कार्यालय ज्ञापन

उपरोक्त के संबंध में, यह प्रस्तुत किया जाता है कि जीएफआर 2017 के नियम 149 में प्रावधान है कि मंत्रालयों या विभागों द्वारा वस्तुओं और सेवाओं की प्रोक्योरमेंट जी ई एम पर उपलब्ध वस्तुओं और सेवाओं के लिए अनिवार्य होगी। इसके अलावा जीएफआर 2017 के नियम 150 में प्रावधान है कि जेम पर उपलब्ध नहीं होने वाली वस्तुओं और सेवाओं के लिए, मंत्रालय/विभागों के प्रमुख वस्तुओं और सेवाओं के आपूर्तिकर्ताओं को भी पंजीकृत कर सकते हैं और ऐसे पंजीकृत विक्रेताओं/आपूर्तिकर्ताओं को जेम पर सूचीबद्ध किया जाना चाहिए, जब वस्तुएं या सेवाएं जेम पर सूचीबद्ध हो जाएं ताकि अधिकतम वस्तुओं और सेवाओं की प्रोक्योरमेंट जेम पोर्टल के माध्यम से की जा सके।

प्रधान लेखा कार्यालय (प्रशासन) आवासन और शहरी कार्य मंत्रालय, निर्माण भवन, नई दिल्ली, भारत सरकार ने कार्यालय ज्ञापन दिनांक 06.01.2022 के साथ-साथ 29 दिसंबर, 2022 के ई-मेल (प्रति संलग्न) के

माध्यम से सूचित किया है कि जेम ने उक्त ई-मेल के साथ एक एक्सेल शीट दस्तावेज़ साझा किया है, जिसमें आवासन और शहरी कार्य मंत्रालय के तहत विभाग/संगठनों द्वारा 01.11.2022 से 30.11.2022 की अवधि के लिए जेम के बाहर जारी निविदाओं पर विस्तृत विश्लेषण किया गया है। जेम ने सूचित किया है कि ये सभी निविदाएं जेम पर जारी की जा सकती थीं। उत्पाद और सेवाओं के लिए कस्टम बोली निर्माण की कार्यक्षमता जेम पोर्टल पर लाइव है और खरीदार जेम पर किसी भी उत्पाद/सेवाओं के लिए बोली बना सकता है, भले ही जेम पर श्रेणी की उपलब्धता कुछ भी हो। एक्सेल में जेम पोर्टल के बाहर हड़को द्वारा की गई 4 प्रोक्योरमेंट (माल के लिए 02 और सेवाओं के लिए 02) शामिल हैं।

इस संबंध में चेन्नई, हैदराबाद और बंगलुरु स्थित क्षेत्रीय कार्यालयों ने जेम के बाहर निविदाएं जारी की हैं।

उपरोक्त की दृष्टि से, मुख्यालय/आरओएस/एचएसएमआई स्थित सभी प्रोक्योरमेंट विभागों से अनुरोध है कि वे संलग्न (ईमेल किए गए) निविदा विवरणों का विश्लेषण पाएं और भविष्य में यह सुनिश्चित करें कि जेम पोर्टल के माध्यम से खरीदी जा सकने वाली सभी वस्तुओं और सेवाओं की प्रोक्योरमेंट केवल जेम पोर्टल के माध्यम से ही की जाए। किसी भी सहायता के लिए, जेम अधिकारियों से संपर्क किया जा सकता है। मुख्यालय का प्रशासन विंग पहले भी मुख्यालय/आरओएस/एचएसएमआई स्थित सभी प्रोक्योरमेंट विभागों को सलाह देता रहा है और एक बार फिर सभी प्रोक्योरमेंट विभागों से इस संबंध में मंत्रालय के निर्देशों का पालन करने का अनुरोध करता है।

सभी क्षेत्रीय प्रमुख/मुख्यालय/एच एस एम आई के सभी प्रोक्योरमेंट डिपार्टमेंट के सूचनार्थ एवं आवश्यक कार्रवाई/अनुपालन हेतु प्रेषित किया जाता है।

यह सक्षम प्राधिकारी के अनुमोदन से जारी किया जाता है।

**OFFICE MEMORANDUM**

**Subject: Registration of suppliers on Government e-Marketplace (GeM) under Rule 150 of General Financial Rules (GFRs 2017).**

Rule 149 of GFRs 2017 provides that the Procurement of Goods and Services by Ministries or Departments will be mandatory for Goods or Services available on GeM. Further, Rule 150 of GFRs 2017, as amended vide OM No. F.1/26/2018-PPD dated 2<sup>nd</sup> April, 2019, provides that for goods and services not available on GeM, Head of Ministry/Department may also register suppliers of Goods and Services and that such registered suppliers should be boarded on GeM as and when the item or service gets listed on GeM.

2. In view of the above provisions of GFRs 2017, buyers need to proactively get their registered and prospective sellers/service providers on-boarded on GeM so that the desired product/service gets listed on GeM and procurement is made through GeM. However, it has been observed that on-boarding of sellers/suppliers of goods and service registered with GeM is still very slow.

3. Therefore, it shall be mandatory for sellers providing Goods and Services to Central Government Organizations to be registered on GeM and obtain a unique GeM Seller ID, at the time of placement of order/acceptance of contract. This ID shall invariably be incorporated in every Supply Order/Contract/Agreement/Purchase Order while awarding any contract/order for procurement by any Central Government Organization governed by the GFRs 2017.

4. For the avoidance of doubt, it is clarified that:

- a. GeM Seller ID is not mandatory at the time of tendering.
- b. It is only required for the successful tenderer at the time of award of contract/placement of order.

5. This requirement may be incorporated in the tender conditions, as far as possible.


6. These instructions will be applicable only where the total amount of the bid is more than Rs.25 lakhs (including all taxes etc.).

7. Following cases shall, however, be exempt from the purview of guidelines contained in para 3 above:

- i. All cases where the order is being placed upon the seller as a result of a Global Tender Enquiry floated by a Central Government Organization.
- ii. All orders pertaining to works contracts

- iii. All supply orders/contracts pertaining to Ministry of Railways (until further orders).
8. These instructions shall come into effect in respect of all orders placed after 1<sup>st</sup> November, 2020.

**Subject: Proposal on Minimum Floor price for minimum wage based Manpower Outsourcing Service.**

The undersigned is directed to refer to Government e-Marketplace (GeM) OM No. 9/JS&ACEO/2022 dated 22.12.2022 regarding the subject cited above and to say as under:

- a. The minimum service charges in the procurement of Manpower Outsourcing Service may be fixed as 3.85% (3% profit plus transaction charges, which are 0.85% at present) as proposed by GeM.
  - b. The procuring entities can also fix the service charge above 3.85% with proper justification on file, wherever required. However, such charges should not exceed 7% (including transaction charges) in any case.
  - c. Least Cost System (LCS) may be considered for procurement, wherever appropriate, especially in high value cases.
