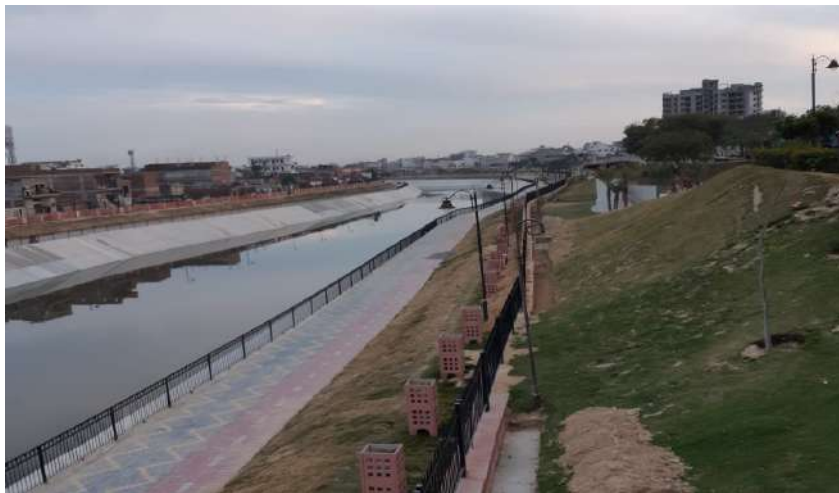

About the Course

Earth's climate has always been changing, due to natural factors. However, in recent years, anthropogenic factors have exacerbated the rate of change. The rapid climate changes being witnessed in the current era are mostly linked to green house gas emissions, environmental degradation and natural resource depletion. Climate change has emerged as a major environmental concern faced by most nations in the world and addressing it is a top priority for governments, business and society worldwide. Climate change poses a series of interrelated challenges to cities. The present course looks at how cities can cope with climate change to achieve sustainable growth. It offers an opportunity for exchange of ideas and information among urban professionals on issues, challenges, strategies and approaches associated with urban climate change for mitigation, adaptation and resilience.

Sensitizing people about climate change is the need of the hour, and is also at the heart of the Sustainable Development Goals and the New Urban Agenda. In this context, this 5-day training programme organized by HUDCO's HSMI and CityNet India National chapter will involve classroom presentations, brain storming sessions, group activities and local study visits.

Objectives of the Course

- To refresh understanding of climate change and related concepts.
- To appreciate how cities are addressing climate change.
- To learn about strategies adopted for mitigation, adaptation and resilience by cities.
- Encourage engagement among participants drawing upon exposure visits, problem analysis and knowledge sharing.

Programme Coverage

The course is designed for urban sector professionals , with a view to impart and exchange information regarding building adaptive capacity and resilience through urban planning strategies , to the impacts of climate change in urban areas. The course contents will include:

- Measures and initiatives taken up by government in India and at global level as well,
- Common global agenda in terms of sustainable development goals and achieving their targets.
- The frameworks for adaptation, mitigation and resilience in respect of urban climate change

Language Of The Course

The course will be conducted in English.

Fees For The Course

HSMI will bear the programme expenses, including cost of lodging and boarding in India and local site visits for all participants. Travel expenses of Indian participants travelling from other cities to New Delhi for the programme, will have to be borne by the participants only. CITYNET will bear the cost of international travel (to and fro airfare) for upto five international participants.
