





The tasks of the professionals are not limited to integration of the built heritage with the urban planning/ development framework but also to exclusively promote and practice conservation, restoration, regeneration and management of valuable built heritage in Indian cities. A comprehensive approach to heritage demonstrates management that economic efficiency, creative people's vigor and participation is the need of the hour. India has a rich. diverse and extensive repository of precious built heritage that is either neglected or at the mercy of unplanned urban development.

Type of projects under this category may be as under or similar projects:

- Preserving Monuments
- Conserving Group of heritage buildings
- Planning & environmental improvement around Archaeological /Cultural heritage sites
- Retrofitting/Restoration/conservation of Heritage buildings
- Protection and management of Heritage Buildings
- Integration of Built heritage with urban planning/development
- Urban Heritage, historical gardens

The built environment contributes 40% of the annual carbon emissions. Reduction in the carbon footprint of the building sector is essential for achieving the Paris agreement for climate change. In a rapidly urbanizing world & increasing built up space, energy efficiency of buildings plays an important role in combatting climate change. It is well established that consumption of energy consequent carbon footprints of buildings can be considerably reduced through adoption of efficient, passive and sustainable design solar & technologies, appropriate choice of green & ecofriendly materials construction & areen practices.

The approach for green building begins with site selection, building planning & orientation and design incorporating measures to reduce water and energy resources and attempts to Net Zero Energy (NZE) i.e. Zero Energy Building (ZEB) .

Type of projects under this category may be as under or similar projects:

- Group Housing/Affordable Housing/Commercial Complex/Institutional/Hotels/Office/ /educational /Individual housing etc. incorporating green building features
- Buildings incorporating Solar passive architecture and sustainable features
- Large (mixed-use) townships: Housing complex, plotted development
- Special Economic Zones

### **Category 5 ANDSCAPE PLANNING & DESIGN**

designing, operation The planning, and management of the built and natural environment for liveable cities is essential for sustainability of human, cultural and urban ecosystem. It is increasingly believed that green open spaces define the culture and character of a city and makes it vibrant and resilient. A well designed and wellmaintained green area adds to the social environmental aspect of the city and also improves psychological and physical wellbeing of citizens.

However, the rapidly modernizing cities are increasingly becoming concrete jungles where the green open places are grossly undervalued and therefore neglected.

Understandably, there is a growing awareness about importance of public places in impacting sustainable development and finds mention in the Sustainable Development Goals (SDGs). The challenge before the professionals is to design safe, inclusive and accessible green spaces that enhance the image of a city and contribute to environmental sustainability. Type of projects under this category may be as under or similar projects:

- Landscape Planning and design for Public Places & Spaces, Parks and open spaces
- Landscaping around Heritage /Institutional/commercial/Residential complexes etc.
- Landscaping & Pedestrian movement in Commercial/Institutional/Educational/Residential complexes etc.
- Landscape planning and design at City level

#### **GENERAL GUIDELINES**

- Presentation of an award to any Entry in no way legalizes project's status.
- If the project (i.e. an Award winning project) is involved in any revenue dispute or in violation of any statutory laws/regulations at subsequent time, the said award has no legal standing or validity in such dispute/violation.

#### SUBMISSION REQUIREMENTS

- There is no restriction to the number of entries that may be submitted by the applicant. However one project may be submitted under one category only. i.e. same project can not be sent in more than one category.
- Entries to be submitted in soft copy (PPT and PDF format) over email. Only entries in PPT and PDF format would be considered.
- The presentation **slides per ENTRY** should not exceed 15 in numbers. It must include slides incorporating latest site photographs of the project **showing actual progress of work**.
- Report with relevant project details like <u>site area, project cost & explaining the concept ,context</u>, <u>constraints, innovations ,construction technology etc.</u> should be **in PDF.**
- The submitted (entries) drawings, reports or documents, SHOULD NOT DISPLAY/PRINT/STICK THE NAME OF PARTICIPANTS/FIRM NAME, FIRM LOGO OR ANY OTHER IDENTIFICATION MARK. OTHERWISE, IT WOULD LEAD TO DISQUALIFICATION.
- A self attested declaration along with Project particulars as per the attached proforma.
- All project entries (completed or in progress) shall be supported by latest site photographs alongwith **DULY FILLED PROFORMA**.

#### **EVALUATION OF ENTRIES**

- Entries complete in all respect as specified will be evaluated by a panel of judges nominated by HUDCO. In all such matters, the decision of HUDCO shall be final.
- Award committee's decisions shall be final and binding on all participants without appeal and cannot be challenged.
- Decisions, deliberations, opinions & proceedings of the jury shall not be made public or otherwise revealed.
- The shortlisted applicants may be required to make a presentation online to the jury members.
- The entry material sent for the Awards will be retained as property of HUDCO. HUDCO shall be free to publish the entries in the Hudco publication. No claim for compensation or otherwise shall be entertained.
