- The number of presentation **slides per ENTRY** should not exceed 15 in numbers.
- **Report with relevant project details** explaining the **c**oncept, **c**ontext, **c**onstraints, **c**reativity/innovations, **c**onstruction technology etc. should be in PDF.
- The submitted (entries) drawings ,reports or documents, **should not display/contain** the name(s) of *firm* or participants , firm's logo or any other identification mark.
