Dear Sir/Ma'am,

The President of India acting through Administrative Ministry, i.e., Ministry of Housing and Urban Affairs (MoHUA), Government of India, vide its Office Order dated 22<sup>nd</sup> October, 2020 assigned the additional charge of the post of Chairman & Managing Director, HUDCO to Shri Kamran Rizvi (DIN: 01653503), Additional Secretary, MoHUA, for a period of 6 months with effect from date of issue of order, or till appointment of regular incumbent to the post, or until further orders, whichever is the earliest. The tenure of Shri Rizvi was further extended by competent authority vide orders dated 1<sup>st</sup> July, 2021, 6<sup>th</sup> December, 2021 and 10<sup>th</sup> May, 2022 respectively.

MoHUA vide Office Order dated 10<sup>th</sup> May, 2022 (Annexure) conveyed that pursuant to ACC approval dated 19<sup>th</sup> April, 2022, the additional charge of the post of CMD, HUDCO assigned to Shri Kamran Rizvi was extended for a further period of 6 months w.e.f., 22.04.2022 or till appointment of regular incumbent to the post, or until further orders, whichever is the earliest. The intimation in this regard was given to Stock Exchanges on 10<sup>th</sup> May, 2022.

Accordingly, as per the aforesaid Office Order dated 10<sup>th</sup> May, 2022, Shri Rizvi ceased to be Chairman & Managing Director (Additional Charge), HUDCO with effect from 22<sup>nd</sup> October, 2022. The communication is hereby given under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.


